Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.5,18,50,000/-, (Rupees Five crores eighteen lakhs fifty thousand only) for the work "Improvements to Ankush Khan Talab, Birkur (V&M), Nizamabad District", under Mission Kakatiya Phase-II for the Financial Year 2016-17 in relaxation of orders issued in the GO 1st read above.
