ORDER:-

In the reference read above, the Chief Engineer, Minor Irrigation (GB), Hyderabad has requested for according administration approval for the work “Conversion of Pedda Cheruvu Tank as Mini Tank bund at Kamareddy, Nizamabad District for an amount of Rs.1190.00 Lakhs, under Mission Kakatiya.

2. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.896.00 Lakhs (Rupees Eight Crores Ninety Six Lakhs only ), for the work “Conversion of Pedda Cheruvu Tank as Mini Tank bund at Kamareddy, Nizamabad District”, under Mission Kakatiya Phase-II, for the Financial Year 2016-17, subject to ensuring the following and the statement showing the details of tank proposed for restoration is annexed to this order:-

- a) The provision made towards de-siltation in the estimates are based on the pre-levels and prudent assessments of quantities involved.
- b) The Cost of repairs indicated are to be limited to the actual requirement of the related components and quantities for restoration and the provisions including L.S. Provisions made are in accordance to the Codal provisions and the guidelines issued in relation thereto.
- c) There is no overlap of proposed works or part of the works under other sanctioned schemes and / or duplication.
- d) To ensure that the proposed components fit into the guidelines issued vide G.O.Ms.No. 89, dated. 15.05.2015.
- e) Pre entrustment procedure may be taken up during 2015-16 and ensure that expenditure is incurred during 2016-17 only in respect of Mission Kakatiya Phase-II programme works.

3. The expenditure sanctioned in para (2) above, shall be chargeable to the head of account "4702 COL on M.I. MH-101-Surface Water GH-11 Normal State Plan SH-(23) – Mission Kakatiya-530 Major works -531 Other Expenditure".

4. The Chief Engineer, Minor Irrigation (GB), Hyderabad shall take necessary action accordingly, complete the work within the stipulated period and furnish the Utilization Certificate to Government.
