**ORDER:-**

Government of Telangana is launching restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. In the reference read above, the Chief Engineer, Minor Irrigation (GB), Hyderabad has requested to accord administration approval for the work “Restoration and Beautification to Large tank Madannapet (V), Narsampet (M), Warangal District, for an amount of Rs.849.50 Lakhs, under Mission Kakatiya with estimate prepared in terms of GO Ms No.89 I&CAD (MI.T) Deptt. Dt.15.05.2015.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.751.00 Lakhs (Rupees Seven Crores Fifty One lakhs only), for the work “Restoration and Beautification to Large tank, Madannapet (V), Narsampet (M), Warangal District”, under Mission Kakatiya Phase– II, for the Financial Year 2016-17, subject to ensuring the following and the statement showing the details of tank proposed for restoration is annexed to this order:-

- a) The provision made towards de-siltation in the estimates are based on the pre-levels and prudent assessments of quantities involved.
- b) The Cost of repairs indicated are to be limited to the actual requirement of the related components and quantities for restoration and the provisions including L.S. Provisions made are in accordance to the Codal provisions and the guidelines issued in relation thereto.
- c) There is no overlap of proposed works or part of the works under other sanctioned schemes and / or duplication.

- d) Pre entrustment procedure may be taken up during 2015-16 and ensure that expenditure is incurred during 2016-17 only in respect of Mission Kakatiya Phase-II.
4. The expenditure sanctioned in para (3) above, shall be chargeable to the head of account "4702-00-101-GH (11) –SH (23) – 530/531 OE".
5. The Chief Engineer, Minor Irrigation (GB), Hyderabad shall take necessary action accordingly, complete the work within the stipulated period and furnish the Utilization Certificate to Government.
6. This order issues with the concurrence of Finance (EBS.IX) Department vide their U.O.No.6830/405/A2/EBS.IX/2015, dt.19-10-2015.
