**ORDER:-**

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

In the reference read above, the Chief Engineer, Minor Irrigation (GB), Hyderabad has requested to accord administration approval for the work “Restoration and conversion of Pedda Cheruvu as “Mini Tank Bund near Rangampet (Revelli) (V) Choppadandi (M) in Karimnagar District, as Mini Tank Bund”, for an amount of Rs.663.10 Lakhs, under Mission Kakatiya.

Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.655.00 lakhs (Rupees Six crores fifty five lakhs only) for the work “Restoration and conversion of Pedda Cheruvu near Rangampet (Revelli) (V) Choppadandi (M) in Karimnagar District, Choppadandi constituency as “Mini Tank Bund” under Mission Kakatiya Phase-II, for the Financial Year 2016-17, in relaxation of guidelines and the statement showing the details of tank proposed for restoration is annexed to this order:-
