ORDER:

The Government of Telangana have entered into Memorandum of Understanding (MoU) with Indian Institute of Technology, Hyderabad, Birla Institute of Technology and Science, Hyderabad campus and the NABARD for taking technical support for implementation of the irrigation projects, particularly Mission Kakatiya in the state of Telangana on 04-02-2016 and subsequently, an Orientation Work shop has been organized in this regard on 10-02-2016 for all the stakeholders to appraise the above institutions of the irrigation projects scenario in the state.

2. In the references 1st & 2nd read above, M/s NABARD Consultancy Services Pvt. Ltd., (NABCONS), Hyderabad have submitted a proposal, offering their consultancy services to the Irrigation & CAD Department, Government of Telangana to conduct Impact Evaluation and Supplementary Studies for the tanks being restored under Mission Kakatiya, in accordance with the MoU entered on 04.2.2016 and also M/s. NABCONS have offered the proposal to take up the above assignment for 400 tanks in the four districts of Medak, Adilabad, Nalgonda and Karimnagar, covering 10% of the total tanks in each district in the 1st Year (Phase –I) of Mission Kakatiya with the total cost of 2,59,45,700/- (Rupees Two Crore Fifty Nine Lakhs Forty Five Thousand Seven Hundred only) inclusive of Service Tax.

3. Government after careful examination in the matter hereby accord Administrative approval for Rs.2,59,45,700/- (Rupees Two Crores Fifty Nine Lakhs Forty Five Thousands and Seven Hundred only) inclusive of Service Tax towards Consultancy assignment on impact evaluation and supplementary studies for Mission Kakatiya tanks, subject to meet the expenditure from the allocated budget only and ensure the correctness of the amount sanctioned.
