ORDER:-

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. The Chief Engineer, Minor Irrigation (KB), Hyderabad in his letter read above has submitted proposal under Mission Kakatiya for the work “Construction of Pin Cheruvu, Kolanpaka (V), Alair (M), in Alair constituency” Nalgonda District as Mini tank Bund for according administrative approval.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs. 5,60,00,000/- (Rupees Five Crores sixty lakhs only) for the work “Construction of Pin Cheruvu, Kolanpaka (V), Alair (M), Nalgonda District in Alair constituency” as Mini tank Bund”, duly following the guidelines issued in G.O. Ms. No. 89, I&CAD (MI-T) Deptt., dt.15.05.2015, during the execution of the work, subject to responsibility of the Chief Engineer, Minor Irrigation (KB), Hyderabad, that the overall sanctions under Mission Kakatiya works shall remain within FRBM Norms and the expenditure shall not exceed the budget allotted during 2016-17 and the provisions made towards de-siltation in the estimates are based on the pre-levels and prudent assessments of quantities involved and the statement showing the details of tank proposed for restoration is annexed to this order:-

4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account “4702 COL on M.I. MH-101-Surface Water GH-11 Normal State Plan SH(23)- Mission Kakatiya – 530 Major works – 531 Other Expenditure”.

5. The Chief Engineer, Minor Irrigation (KB), Hyderabad, shall take necessary action accordingly to complete the work within the stipulated period and submit the utilization certificate to Government.
