ORDER:-

Government of Telangana is launching restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. In the reference read above, the Chief Engineer, Minor Irrigation (GB), Hyderabad has submitted proposals under Mission Kakatiya for the work “Repairs to Thamma Cheruvu and conversion as Mini Tank Bund in Manthani (V&M) in Karimnagar District, for an amount of Rs.415.60 Lakhs, for according administrative approval.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.315.00 Lakhs (Rupees Three crores fifteen lakhs only) for the work “Repairs to Thamma Cheruvu and conversion as Mini Tank Bund in Manthani (V&M) in Karimnagar District”, under “Mission Kakatiya Phase-II,” for the Financial Year 2016-17, subject to ensure that the provisions made are in accordance to the guidelines framed for the estimation of Mini Tank Bund, and the statement showing the details of tanks proposed for restoration is annexed to this order:-

4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account “4702-00-101-11-23-530/531-O.E”.

5. The Chief Engineer, Minor Irrigation (GB), Hyderabad, shall take necessary action accordingly, complete the work within the stipulated period and submit the utilization certificate to Government.
