ORDER:-

Government of Telangana is launching restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. In the letter read above, the Chief Engineer, Minor Irrigation (KB), Hyderabad has requested to accord administration approval for the work “Beautification of Vallabha Rao Tank (Bathukamma Cheruvu) as Mini Tank Bund, Arjalbavi (V), Nalgonda Mandal and Constituency, Nalgonda District”, for an amount of Rs.586.00 Lakhs.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.513.00 lakhs (Rupees five crores thirteen lakhs only) for the work Beautification of Vallabha Rao Tank (Bathukamma Cheruvu) as Mini Tank Bund, Arjalbavi (V), Nalgonda Mandal and Constituency, Nalgonda District” under Mission Kakatiya Phase–II, for the Financial Year 2016-17, subject to ensuring the following and the statement showing the details of tank proposed for restoration is annexed to this order:-

- a) The provision made towards de-siltation in the estimates is based on the pre-levels and prudent assessments of quantities involved.
- b) The cost of repairs indicated are to be limited to actual requirement of the related components and quantities for restoration and the provisions including L.S Provisions made are in accordance to the Codal provisions and the guidelines issued in relations thereto.
- c) There is no overlap of proposed work or part of the work under other sanctioned schemes and / or duplication.
- d) Keeping in view of the budgetary requirement for the total Mission Kakatiya Phase-II Programme, the Chief Engineer, Minor Irrigation (KB) is advised to take up the items of works as per the G.O.Ms.No.89, dated 15.05.2015 as per minimum requirement at work site within the sanctioned cost and ask for no further Revision of estimate at a later date.

- e) Pre entrustment procedure may be taken up during 2015-16 and ensure expenditure to be incurred during 2016-17 only.
4. The expenditure sanctioned in para (3) above, shall be chargeable to the head of account "4702-00-101-GH (11) –SH (23) – 530/531 OE".
5. The Chief Engineer, Minor Irrigation (KB), Hyderabad shall take necessary action accordingly, complete the work within the stipulated period and furnish the Utilization Certificate to Government.
