**ORDER:-**

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State to their original capacity and to effectively utilize water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. The Chief Engineer, Minor Irrigation (KB), Hyderabad in his letter 1<sup>st</sup> read above, has submitted proposal under Mission Kakatiya Phase-III for “Comprehensive Restoration of (41) Minor Irrigation Tanks in Yadadri-Bhongir District” for according administrative approval.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs. 11,41,46,000/- (Rupees Eleven Crores Forty One lakhs and Forty Six Thousand Only) towards “Comprehensive Restoration of (41) Minor Irrigation Tanks in Yadadri-Bhongir District” for the Financial Year 2017-18 under Mission Kakatiya phase-III Programme, subject to the responsibility of the Chief Engineer, Minor Irrigation (KB), Hyderabad, to follow the following points while giving Technical Sanction and while executing the work. The statement showing the details of tank proposed for restoration is annexed to this order:-

- 1) He must ensure and satisfy from the history of repairs carried to the tanks that there are no overlap of proposed repairs in any other previous sanctioned schemes, now on-going are taken up recently.
- 2) The cost of repairs must be arrived after thorough investigation and as per the actual requirement of components and quantities for restoration and the provisions made including lump sum provisions are in terms of codal provisions and the guidelines issued in relation thereto.
- 3) Wherever applicable de-siltation provision made in the estimates are based pre-levels and prudent assessment of quantities involved and in consideration of nature of percolation and potential of the yield.
- 4) Follow due procurement procedures for taking up the works.
- 5) Dismantling of existing damage Structures and construction of new weir and sluice shall be done only in rare cases after due examination of the possibilities of repairs of the existing damage structures at a level not lower than Superintending Engineer.

- 6) Ensure sufficient funds in 2017-18 BE to meet the expenditure towards MK programme works including sanctions considered now before giving technical sanction
4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account "4702 COL on M.I. – MH (101) Surface Water-GH (11) Normal State Plan –SH (23) Mission Kakatiya -530 Major works – 531 Other Expenditure".
5. The Chief Engineer, Minor Irrigation (KB), Hyderabad, shall take necessary action accordingly, complete the work within the stipulated period and submit the utilization certificate to Government. The (41) estimates received vide letter 1<sup>st</sup> read above are returned herewith and he is requested to acknowledge receipt of the same.
6. This order issues with the concurrence of Finance (EBS.IX) Department vide their U.O.No.2335 / 118/A2/EBS.IX/2017, dated:07-03-2017.
