ORDER:-

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State to their original capacity and to effectively utilize water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. The Chief Engineer, Minor Irrigation (KB), Hyderabad in his letter 2nd read above, has submitted proposal under Mission Kakatiya-III for “Restoration and conversion of Mini Tank Bund of Bheemanapally Project, Bheemanapally (V) Devarkonda (M), Nalgonda District”, for according administrative approval.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.6,32,35,000/- (Rupees Six Crores Thirty Two Lakhs and Thirty Five thousand only) towards “Restoration and conversion of Mini Tank Bund of Bheemanapally Project, Bheemanapally (V) Devarkonda (M), Nalgonda District” for the Financial Year 2017-18 under Mission Kakatiya phase-III Programme, subject to condition, that the Chief Engineer, Minor Irrigation (KB), Hyderabad to follow the guidelines issued in the G.O.1st cited, during the execution of work. The statement showing the details of tank sanctioned for restoration is annexed to this order:-

4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account “4702 COL on M.I. – MH (101) Surface Water-GH (11) Normal State Plan – SH (23) Mission Kakatiya -530 Major works – 531 Other Expenditure”.

5. The Chief Engineer, Minor Irrigation (KB), Hyderabad, shall take necessary action accordingly to complete the work within the stipulated period and submit the utilization certificate to Government. The estimate received vide letter 2nd read above are returned herewith and he is requested to acknowledge receipt of the same.
