ORDER:-

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. In the references 1st to 4th read above, the Chief Engineer, Minor Irrigation (GB), Hyderabad has requested to accord administration approval for the work “Strengthening, widening of Bund of Wyra MIP and Conversion as Mini Tank Bund in Wyra Assembly Constituency, Khammam District” for Rs.912.00 Lakhs, under Mission Kakatiya.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.5,70,31,000/- (Rupees Five Crores Seventy Lakhs and Thirty one thousand only) for the Financial Year 2017-18 for the work “Strengthening, widening of Bund of Wyra Medium Irrigation Project and Conversion as Mini Tank Bund in Wyra Assembly Constituency, Khammam District” with solar lighting under Mission Kakatiya Phase–III, in relaxation of guidelines issued in G.O.Ms.No.89 I & CAD(MIT) Dept., Dt.15.05.2015, subject to condition that, to take up the work only after freezing of work components by thorough investigation and arriving the actual cost estimation and to follow guidelines while executing the work.

4. The expenditure sanctioned in para (3) above, shall be chargeable to the head of account "4702 COL on M.I. MH-101-Surface Water GH-(25) State Sector Schemes SH-(23) –Mission Kakatiya - 530 Major works – 531 Other Expenditure".

5. The Chief Engineer, Minor Irrigation (GB), Hyderabad shall take necessary action accordingly to complete the work within the stipulated period and furnish the Utilization Certificate to Government.
