ORDER:-

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of "MISSION KAKATIYA".

2. In the reference read above, the Chief Engineer, Minor Irrigation (KB), Hyderabad has requested for according Administrative approval for the work "Restoration of the Nallacheru at Jadcherla (V&M) Mahabubnagar District", converted as Mini Tank Bund.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.5,05,00,000/- (Rupees Five crores and five lakhs only) for the work "Restoration of Nallacheru at Jadcherla (V&M) Mahabubnagar District converted as Mini Tank Bund", with an instruction to follow the guide lines issued vide G.O.Ms.No.89, I&CAD (MI-T)Deptt., dt.15.05.2015, during execution of the work, subject to the responsibility of the Chief Engineer, Minor Irrigation(KB), Hyderabad that the overall sanctions remain within the FRBM limitations, to meet the expenditure not exceeding the overall BE provision allotted during 2017-18 and to ensure and satisfy that the provisions made in the estimate are in accordance to the MTB guidelines, and the statement showing the details of tank sanctioned for restoration is annexed to this order.

4. The expenditure sanctioned in para (3) above, shall be chargeable to the head of account "4702 COL on MI – MH – 101 – GH – 25 – SH (23) – 530/531 other Expenditure".

5. The Chief Engineer, Minor Irrigation (KB), Hyderabad shall take necessary action accordingly, complete the work within the stipulated period and furnish the Utilization Certificate to Government.
