ORDER:-

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. The Chief Engineer, Minor Irrigation (GB), Hyderabad in his letter read above has submitted the proposal under Mission Kakatiya for the work “Restoration and conversion of Pedda Cheruvu, Thorrur (V&M), Warangal District as Mini Tank Bund” for according administrative approval.

Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.3,60,00,000/- (Rupees Three Crores sixty lakhs) towards “Restoration and conversion of Pedda Cheruvu, Thorrur (V&M), Warangal District as Mini Tank Bund”, under Mission Kakatiya Phase-II for the Financial Year 2016-17 with an instructions to the Chief Engineer, Minor Irrigation(GB) Hyderabad to follow the MTB guidelines issued in G.O. Ms. No. 89, I&CAD (M.I.T), Department, Dt. 15.05.2015, subject to the responsibility of the Chief Engineer, Minor Irrigation (GB), Hyderabad, that the overall sanctions under Mission Kakatiya works shall remain within FRBM Norms and the expenditure shall not exceed the budget allotted during 2016-17 and the statement showing the details of tank proposed for restoration is annexed to this order.

4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account “4702 COL on M.I. MH-101-Surface Water GH-11 Normal State Plan SH(23)- Mission Kakatiya – 530 Major works – 531 Other Expenditure”.
