**ORDER:-**

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State to their original capacity and to effectively utilize water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. The Chief Engineer, Minor Irrigation (GB), Hyderabad in his letter read above has requested the Government to accord Stage-I administrative approval for the work “Re-sectioning of Feeder Channel from Anicut to Oora Cheruvu, Dharmaraopet (V), Dandepally (M), Mancherial District” for an amount of Rs.92.00 Lakhs, under Mission Kakatiya Phase-IV.

3. Government after careful examination of the matter, hereby accord Stage-I administrative approval for an amount of Rs.15,10,000/- (Rupees Fifteen Lakhs and Ten Thousand only) towards “Re-sectioning of Feeder Channel from Anicut to OoraCheruvu, Dharmaraopet (V), Dandepally (M), Mancherial District” for the Financial Year 2018-19 under Mission Kakatiya phase-IV Programme.

4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account "4702-COL on MI 101 Surface Water – GH-25 State Sector Schemes – SH (23) – Mission Kakatiya – 530 Major Works – 531 Other Expenditure”.

5. The Chief Engineer, Minor Irrigation (GB), Hyderabad, shall take necessary action accordingly to complete the work within the stipulated period and submit the utilization certificate to Government.
