The Chief Engineer, Minor Irrigation (GB), Hyderabad in his letter read above has informed that there is no suitable Minor Irrigation source for renovation in Mudhole Constituency as recreational Zone. Hence he has selected Gaddannavagu Medium Irrigation Project and requested the Government for according administrative approval for the work "Beautification of Gaddennavagu Medium Irrigation Project, Near Bhainsa (V&M), Adilabad District, Conversion as Mini Tank Bund.
- 3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs. 3,64,00,000/- (Rupees Three Crores and sixty four lakhs only) for the work "Beautification of Gaddennavagu Medium Irrigation Project, near Bhainsa (V&M) Adilabad District conversion as Mini tank Bund", as a special case in relaxation of guidelines and rules issued in GOs 1st and 2nd read above. The Chief Engineer, Minor Irrigation(GB), Hyderabad is requested to follow the guidelines issued in the GO 2nd read above, during the execution of the work, and the statement showing the details of tank proposed for restoration is annexed to this order
- 4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account "4702 COL on M.I. MH-101-Surface Water GH-11 Normal State Plan SH(23)- Mission Kakatiya 530 Major works 531 Other Expenditure".
