ORDER:-

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. The Chief Engineer, Minor Irrigation (GB), Hyderabad in his letters 5th to 7th read above has informed that, the formers and local representatives are requested for sanction of following (3) tanks located in Mandal Head Quarters in Siricilla Assembly Constituency are restored in Mission Kakatiya Phase-I and which are to be taken up as Mini Tank bunds under Mission Kakatiya Phase-III as a special case for development of Tourism in Sircilla Constituency. Accordingly, the Chief Engineer, Minor Irrigation (GB), Hyderabad has requested for according administrative approval for the following (3) Mini tank Bunds.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.15,03,54,000/- (Rupees Fifteen Crores Three Lakhs and Fifty Four Thousand only) for the above (3) tanks to convert as Mini Tank Bunds in Rajanna Siricilla District for the Financial Year 2017-18 under Mission Kakatiya phase-III, in relaxation of orders issued in the G.O.s 1st and 2nd read above subject to the responsibility of the Chief Engineer, Minor Irrigation (KB), Hyderabad to follow the following points while giving Technical Sanction and while executing the work and also instructed to follow the guidelines issued in the G.O. 2nd read above. The statement showing the details of tanks sanctioned as Mini Tank Bunds are annexed to this order,

1. The Chief Engineer must ascertain the correctness of quantities and provisions made in the estimate before according Technical sanction.

2. Take photographs of works before and after execution.

4. The expenditure sanctioned in para (3) above, shall be chargeable to the Head of Account "4702-00-101-GH (25) –SH (23) – 530/531 OE".

5. The Chief Engineer, Minor Irrigation (GB), Hyderabad shall take necessary action accordingly to complete the work within the stipulated period and furnish the Utilization Certificate to Government. The (03) estimate received through the letters 5th and 7th read above are returned herewith.
