ORDER:-

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State to their original capacity and to effectively utilize water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. In the G.O.2nd read above, the Government have accorded administrative sanction for the subject work for Rs.446.00 Lakhs in Mission Kakatiya Phase-I and cancel the administrative approval accorded for the subject work in Mission Kakatiya Phase-I vide G.O.4th read above.

3. In the letter 5th and 7th read above, the Chief Engineer, Minor Irrigation, Hyderabad has requested the Government to accord administrative approval for the work “Repairs & Restoration of Rallavagu and Rallavagu Pick up dam, Karegattu(V), Paloncha(M), Bhadradi Kothagudem District” for an amount of Rs.5005.00 Lakhs, under Mission Kakatiya Phase-IV.

4. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.5003.50 lakhs (Rupees Fifty Crores Three Lakhs and Fifty Thousand only) towards “Repairs & Restoration of Rallavagu and Rallavagu Pick up dam, Karegattu(V), Paloncha(M), Bhadradi Kothagudem District” for the Financial Year 2018-19, in relaxation of the orders issued in the G.O.1st read above and instructed the Chief Engineer, Minor Irrigation, Hyderabad must follow the following points while giving technical sanction and while execute the work. The above expenditure may be charged to the Head account “4702 COL on M.I. – MH 101 Surface Water - GH-25 Normal State Plan SH (23) – Mission Kakatiya – 530 Major Works – 531 Other Expenditure”.

- i. Ensure and satisfy from the history of repairs carried to the tanks that there are no overlap of proposed repairs in any other previous sanctioned schemes.

- ii. The provisions in the estimate are arrived after thorough investigation and as per the actual requirement of components for the work and the lump sum provisions are in terms of codal provisions and the guidelines issued in the relation thereto.
- iii. Whenever applicable, the de-siltation provision made in the estimates are based pre-levels and prudent assessment of quantities involved and in consideration of nature of percolation and potential of the yield.
- iv. Follow due procurement procedures for taking up the works.
- v. Ensure sufficient funds in 2018-19 BE to meet the expenditure towards MK programme works including sanctions considered now.
- vi. To recheck works arithmetical accuracy of individual provisions and total estimate cost before according technical sanction as the estimates are with number of corrections.
- vii. Dismantling of existing damage Structures and construction of new weir and sluice shall be done only in rare cases after due examination of the possibilities of repairs of the existing damage structures at a level not lower than Superintending Engineer.
- viii. Ensure and satisfy the cost benefit implications of the proposed tanks.

5. The expenditure sanctioned in para (4) above shall be debited to the Head of Account "4702-COL on MI 101 Surface Water – GH-25 State Sector Schemes – SH (23) – Mission Kakatiya – 530 Major Works – 531 Other Expenditure”.

6. The Chief Engineer, Minor Irrigation (GB), Hyderabad, shall take necessary action accordingly to complete the work within the stipulated period and submit the utilization certificate to Government. The (1) estimate received through the letter 1st read above is returned herewith.
