ORDER:-

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. In the reference read above, the Chief Engineer, Minor Irrigation (GB), Hyderabad has requested to accord administration approval for the work “Restoration of Naidu Kunta, Manuguru (V&M) at Manuguru (M), Khammam District, Conversion as Mini Tank Bund”, for an amount of Rs.230.00 Lakhs, under Mission Kakatiya.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.223.00 lakhs (Rupees Two crores twenty three lakhs only) for the work “Restoration of Naidu Kunta, Manuguru (V&M) at Manuguru (M), Khammam District, Conversion as Mini Tank Bund”, in Pinapaka Assembly Constituency under Mission Kakatiya Phase–II, for the Financial Year 2016-17, in relaxation of Mini Tank Bund guidelines (since the tank proposed does not exist in constituency head quarters) subject to ensuring the following and the statement showing the details of tank proposed for restoration is annexed to this order:-

4. The expenditure sanctioned in para (3) above, shall be chargeable to the head of account “4702-00-101-GH (11) –SH (23) – 530/531 OE”.

5. The Chief Engineer, Minor Irrigation (GB), Hyderabad shall take necessary action accordingly, complete the work within the stipulated period and furnish the Utilization Certificate to Government.
