In the reference read above, the Chief Engineer, Minor Irrigation (GB), Hyderabad has requested to accord administration approval for the work "Improvements to Pedda Cheruvu (Ooracheruvu), Mulkanur (V), Chigurumamidi (M) Karimnagar District", for an amount of Rs.98.20 Lakhs, under Mission Kakatiya, as the Hon'ble Chief Minister, Telangana, adopted the Mulkanur Village.

- 2.  - a) The provision made towards de-silatation in the estimates are based on the pre-levels and prudent assessments of quantities involved.
 - b) The Cost of repairs indicated are to be limited to the actual requirement of the related components and quantities for restoration and the provisions including L.S. Provisions made are in accordance to the Codal provisions and the guidelines issued in relation thereto.
 - c) There is no overlap of proposed works or part of the works under other sanctioned schemes and / or duplication.
 - d) Pre entrustment procedure may be taken up during 2015-16 and ensure that expenditure is incurred during 2016-17 only in respect of Mission Kakatiya Phase-II programme works.
