ORDER:-

Government of Telangana is launching restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of "MISSION KAKATIYA".

- 2. In the reference first and third read above, the Chief Engineer, Minor Irrigation (K), Hyderabad has submitted proposals under "Mission Kakatiya" for "(i) Restoration of Chevella Cheruvu/ Gundam (Sri Venkateshwara Swamy Pushkarni) for Rs.72.70 Lakhs. (ii) Restoration of Pedda Cheruvu for Rs.777.50 Lakhs and (iii) Restoration and Mini tank bund of Pailwan Cheruvu, for Rs.1165.53 Lakhs for according administrative approval.
- 3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs. 558.50 Lakhs (Rupees five Crores fifty eight lakhs and fifty thousand only) towards the comprehensive "(i) Restoration of Chevella Cheruvu/ Gundam (Sri Venkateshwara Swamy Pushkarni) Chevella (V) & (M) of Ranga Reddy District for an amount of Rs.35.00 Lakhs. (ii) Restoration of Pedda Cheruvu Chandana vally (V), Shabhad (M) Ranga Reddy District for an amount of Rs.523.50 Lakhs", for the Financial year 2016-17 subject to ensuring the following and the statement showing the details of tank proposed for restoration is annexed to this order:-
- (a) The Provision made towards de-siltation in the estimates are based on the pre-levels and prudent assessments of quantities involved.
- (b) The cost of repairs indicated are as per the actual requirement of the related components and quantities for restoration and the provisions including L.S Provisions made are in accordance to the Codal provisions and the guidelines issued in relation thereto.

- (c) There is no overlap of proposed works or part of the works under other sanctioned schemes and / or duplication.
- (d) Pre entrustment procedure may be taken up during 2015-16 and ensure that expenditure to be incurred during 2016-17 only in respect of Mission Kakatiya-Phase –II.
- 4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account "4702 COL on M.I. MH-101-Surface Water GH-11 Normal State Plan SH-(23) –Mission Kakatiya 530 Major works 531 Other Expenditure".
- 5. The Chief Engineer, Minor Irrigation (KB), Hyderabad, shall take necessary action accordingly, complete the work within the stipulated period and submit the utilization certificate to Government.
