**ORDER:-**

Government of Telangana is launching restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of "MISSION KAKATIYA".

2. In the reference read above, the Chief Engineer, Minor Irrigation (K), Hyderabad has submitted the estimate for the work "Improvements to Feeder Channel of Chowdary Cheruvu (Eti Kaluva), papannapet (M) Medak District" for an amount of Rs.75.55 Lakhs for according administrative approval.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs. 75.55 Lakhs (Rupees seventy five lakhs and fifty five thousand only) for the work "Improvements to Feeder Channel of Chowdary Cheruvu (Eti Kaluva), Papannapet (M) Medak District" under "Mission Kakatiya Phase-II" subject to ensuring the following and the statement showing the details of tank proposed for restoration is annexed to this order:-

- a) The Provision made towards de-siltation in the estimates is based on the pre-levels and prudent assessments of quantities involved.
- b) There is no overlap of proposed work or part of the work under other sanctioned schemes and / or duplication.
- c) Pre entrustment procedure may be taken up during 2015-16 and ensure that expenditure of MK-Phase –II is incurred during 2016-17 only.

4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account "4702 COL on M.I. MH-101-Surface water GH-11 Normal State Plan SH-(23)-Mission Kakatiya-530 Major works -531 Other expenditure".

5. The Chief Engineer, Minor Irrigation (KB), Hyderabad, shall take necessary action accordingly, complete the work within the stipulated period and submit the utilization certificate to Government.
