**ORDER:-**

Government of Telangana is launching restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of "MISSION KAKATIYA".

2. In the reference read above, the Chief Engineer, Minor Irrigation (KB), Hyderabad has submitted proposals under Mission Kakatiya for (i) "Restoration of Budani Kunta, Dubbak(V&M), Medak District" and (ii) "Improvements to Sathi Kunta, Thimmapur (V), Dubbak(M), Medak District", for totaling an amount of Rs. 58.79 lakhs, for according administrative approval.

3. Government after careful examination of the matter, hereby accord administrative approval for totaling an amount of Rs. 52.00 Lakhs (Rupees fifty two lakhs only) towards the works "(i) Restoration of Budani Kunta, Dubbak(V&M), Medak District" for an amount of Rs. 22.10 lakhs and (ii) "Improvements to Sathi Kunta, Thimmapur (V), Dubbak(M), Medak District", for an amount of Rs. 29.90 lakhs under "Mission Kakatiya phase -II" subject to ensuring the following and the statement showing the details of tank proposed for restoration is annexed to this order:-

- a) The Provision towards de-siltation made in the estimate are based on the pre-levels and prudent assessments of quantities.
- b) The Cost of repairs indicated against each tank is arrived after thorough investigation and as per the actual requirement of components and quantities for restoration and the provisions made are in terms of the codal provisions and the guidelines issued in relation thereto, and that the provisions made towards de-siltation in the estimates are based on the prudent assessments of quantities involved.
- c) There is no overlap of proposed works under any other sanctioned schemes and / or duplication.
- d) Pre entrustment procedure may be taken up during 2015-16 and ensure that expenditure of MK-Phase –II to be incurred during 2016-17 only.

4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account "4702-00-101-11-23-530/531-O.E".

5. The Chief Engineer, Minor Irrigation (KB), Hyderabad, shall take necessary action accordingly, complete the work within the stipulated period and submit the utilization certificate to Government.
