## **ORDER:-**

Government of Telangana is launching restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of "MISSION KAKATIYA".

- 2. In the reference read above, the Chief Engineer, Minor Irrigation (KB), Hyderabad has submitted proposals for restoration of 3 Minor Irrigation Tanks in Medak District for an amount Rs. 153.60 lakhs under Mission Kakatiya Phase-II." for according administrative approval.
- 3. Government after careful examination of the matter, hereby accord administrative approval for an amount ofRs.75.50 Lakhs (Seventy five lakhs and fifty thousand only) towards the work "(1) Patel Kunta, Nagulapally(V), Toopran(M), Medak District, for an amount of 28.00 Lakhs and (2) Oora Cheruvu, Kallakal (V) Toopran(M), Medak District, for an amount of Rs.47.50 Lakhs under "Mission Kakatiya phase -II" subject to ensuring the following and the statement showing the details of tank proposed for restoration is annexed to this order:-
- (a) The Provision made towards de-siltation in the estimates are based on the prelevels and prudent assessments of quantities.
- (b) The Cost of repairs indicated against each tank is arrived after thorough investigation and as per the actual requirement of components and quantities for restoration and the provisions made are in terms of the codal provisions and guidelines issued in relation thereto, and that the provisions made towards de-siltation in the estimates are based on the pre-level and prudent assessments of quantities involved.
- (c) There is no overlap of proposed works or part of the works under other sanctioned schemes and / or duplication.

- (d) Pre entrustment procedure may be taken up during 2015-16 and ensure that expenditure to be incurred during 2016-17 only.
- 4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account "4702-00-101-11-23-530/531-O.E".
- 5. The Chief Engineer, Minor Irrigation (KB), Hyderabad, shall take necessary action accordingly, complete the work within the stipulated period and submit the utilization certificate to Government.
