ORDER:-

Government of Telangana is launching restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. In the reference read above, the Chief Engineer, Minor Irrigation (GB), Hyderabad has submitted proposals under “Mission Kakatiya” for comprehensive restoration of (15) tanks in Warangal District for according administrative approval for an amount of Rs.154.51 Lakhs.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.154.51 Lakhs (Rupees Fifteen crores four lakhs and fifty one thousand only) towards the comprehensive restoration of (15) Minor Irrigation tanks in Warangal District under “Mission Kakatiya phase-II, for the Financial Year 2016-17 subject to ensuring the following and the statement showing the details of tanks proposed for restoration is annexed to this order:-

1) That the cost of repairs indicated against each tank is arrived after thorough investigation and as per the actual requirement of components and quantities for restoration and all the provisions made including L.S. Provisions if any are in terms of the codal provisions and the guidelines issued in relation thereto, and that the provisions made towards de-siltation in the estimates are based on the pre-levels and prudent assessment of quantities involved.

2) There is no overlap of proposed works under other sanctioned schemes and / or duplication.

3) Pre entrustment procedure may be taken up during 2015-16 and ensure that expenditure of MK-Phase-II to be incurred during 2016-17 only.

4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account "4702-00-101-GH (11) –SH (23) – 530/531 OE".

5. The Chief Engineer, Minor Irrigation (GB), Hyderabad shall take necessary action accordingly and to complete the work within the stipulated period without fail and furnish utilization certificate to Government for the amount sanctioned in Para (3) above. The estimates received vide reference read above are returned herewith and he is requested to acknowledge receipt of the same.
