ORDER:-

Government of Telangana is launching restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. In the reference read above, the Chief Engineer, Minor Irrigation (KB), Hyderabad has submitted proposal under Mission Kakatiya for “Restoration & Renovation of old Anicuts on Kudlair vagu and Remodeling of Kudlair vagu from Surplus weir Pedda cheruvu, Chebarthy(V) to Itikyala(V), from 0.40km to 7.20km (i.e from surplus course of pedda cheruvu, chebarthy(v) to Itikayal(V) Jagadevpur (M) Medak(Dist) for Rs.2880.00 Lakhs, for according administrative approval.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs. 2880.00 Lakhs (Rupees Twenty eight crores eighty lakhs only) towards the work “Restoration & Renovation of old Anicuts on Kudlair vagu and Remodeling of Kudlair vagu from Surplus weir Pedda cheruvu, Chebarthy(V) to Itikyala(V), from 0.40km to 7.20km (i.e from surplus course of pedda cheruvu, chebarthy(v) to Itikayal(V) Jagadevpur (M) Medak(Dist)” under “Mission Kakatiya Phase-II,” with a direction to the CE to contact ENC (Irrigation) and CE,CDO to get finalize the proposals along with designs and drawings before according technical sanction subject to ensuring the following and the statement showing the details of tank proposed for restoration is annexed to this order:-

- a. There is no overlap of proposed works or part of the works under other sanctioned schemes and / or duplication.
- b. Keeping in view of the budgetary requirement for the total Mission Kakatiya Phase-II Programme, the Department is advised to take up the items of works as per minimum requirement at work site within the sanctioned cost and no further Revision of estimate at a later date.
- c. The due administrative and technical sanctions precede initiation of tender process.

- d. Pre entrustment procedure may be taken up during 2015-16 and ensure that expenditure to be incurred during 2016-17 only.

4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account "4702-00-101-11-23-530/531-O.E".
5. The Chief Engineer, Minor Irrigation (KB), Hyderabad, shall take necessary action accordingly, complete the work within the stipulated period and submit the utilization certificate to Government.
