ORDER:

In the G.O 2nd read above, orders were issued according administrative approval for the work “Restoration and Beautification of Gandhi Cheru, as Mini Tank Bund, Yadagiripally (V), Yadagirigutta (M), Yadadri-Bhongir District, erstwhile Nalgonda District” for an amount of Rs.129.00 Lakhs along with other Mini Tank Bunds in Nalgonda District.

2. In the letter 3rd read above, the Engineer-in-Chief (I.W), Hyderabad has informed that, the Committee of Chief Engineers has examined the deviations in the Revised Estimate and after detailed discussions, the Committee of Chief Engineers Recommended to the Government for Revised Administrative sanction for Rs.400,00,000/- for “Restoration and Beautification of Gandhi Cheru, as Mini Tank Bund, Yadagiripally (V), Yadagirigutta (M), Yadadri-Bhongir District, erstwhile Nalgonda District”.

3. Government after careful examination of the matter, hereby accord Revised Administrative Approval for an amount of Rs.3,21,60,000/- (Rupees Three Crores and Twenty One Lakhs and Sixty thousand Only) including tender discount for the work “Restoration and Beautification of Gandhi Cheru, as Mini Tank Bund, Yadagiripally (V), Yadagirigutta (M), Yadadri-Bhongir District, erstwhile Nalgonda District” under Mission Kakatiya for the Financial year 2018-19 in relaxation of orders issued in the G.O.1st read above and the Chief Engineer is responsible for the correctness of quantities provided in the revised estimate and also directed to meet the additional cost from the available budget.

4. The expenditure sanctioned in para (3) above shall be debited to the Head account "4702 COL on M.I. MH-101-Surface Water GH-25 State Sector Plan SH-(23) – Mission Kakatiya – 530 Major works – 531 Other Expenditure”.
