ORDER:-

In the G.O.1st read above, Government have accorded administrative approval for an amount of Rs.116.91 lakhs for the work “Repairs and Restoration of Erra Cheruvu, Danthelaboru (V), Paloncha (M), Bhadradi Kotha Gudem District”.

2. In the letter 2nd read above, the Engineer-in-chief (I.W), Hyderabad has informed that, the committee of Chief Engineers has examined the deviations in the Revised Estimate and after detailed discussions, the Committee of Chief Engineers Recommended to the Government for Revised Administrative sanction for an amount of Rs.5,19,00,000/- for the work “Repairs and Restoration of Erra Cheruvu, Danthelaboru (V) Polancha (M) Bhadradi Kotha Gudem District District”

3. Government after careful examination of the matter, hereby accord revised administrative approval for an amount of Rs.4,43,95,800/- (Rupees Four Crores forty three lakhs and ninety five thousand eight hundred only) including tender discount towards “Repairs and Restoration of Erra Cheruvu, Danthelaboru (V) Polancha (M) Bhadradi Kotha Gudem District ” subject to condition that the additional cost must be met from the savings out of available budget only.

4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account "4702-COL on MI 101 Surface Water – GH-25 State Sector Schemes – SH (23) – Mission Kakatiya – 530 Major Works – 531 Other Expenditure”.

5. The Chief Engineer, Minor Irrigation (GB), Hyderabad, shall take necessary action accordingly to complete the work within the stipulated period and submit the utilization certificate to Government.
