ORDER:-

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State to their original capacity and to effectively utilize water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. The Chief Engineer, Minor Irrigation (GB), Hyderabad in his letters 1st and 3rd read above has requested the Government to accord stage-I and stage-II administrative approval for the work Construction of Feeder Channel to Mysamma Cheruvu from off take at km.2.630 on 23L minor of DBM-48 of SRSP Stage-I at Anantharam (V), Mahabubabad (M), Mahabubabad District” for Rs.170.15 lakhs, under Mission Kakatiya Phase-IV.

3. Government after careful examination of the matter, hereby accord administrative approval for Stage-I and Stage-II for an amount of Rs.1,27,10,000/- (Rupees One Crore Twenty Seven Lakhs and Ten Thousand Only) (Rs.50.10 Lakhs for Stage- I and Rs.77.00 Lakhs Stage-II) towards “Construction of Feeder Channel to Mysamma Cheruvu from off take at km.2.630 on 23L minor of DBM-48 of SRSP Stage-I at Anantharam (V), Mahabubabad (M), Mahabubabad District” for the Financial Year 2018-19 under Mission Kakatiya Phase-IV Programme, subject to the responsibility of the Chief Engineer, Minor Irrigation (GB) Hyderabad to follow the following points while giving Technical Sanction and while executing the work.

1. Correctness of provisions/quantities provided in the estimate.
2. Ensure that the land acquisition is completed before according Technical Sanction for Stage-II Administrative approval.
3. Ensure sufficient funds to take up the works

4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account "4702-COL on MI 101 Surface Water – GH-25 State Sector Schemes – SH (23) – Mission Kakatiya – 530 Major Works – 531 Other Expenditure”.

5. The Chief Engineer, Minor Irrigation (GB), Hyderabad, shall take necessary action accordingly to complete the work within the stipulated period and submit the utilization certificate to Government. The (01) estimate received through the letter 1st read above are returned herewith.
