ORDER:-

The Engineer-in-Chief (General), Hyderabad in his letter 3rd read above, while stating the facts and circumstances of the work Construction of Check dam across Akeru Vagu near Jayapuram Village of Narsimhulapet Mandal, Mahabubabad District” has requested the Government to accord Revised Administrative Approval to the Variation Estimate which was approved by the SLSC in their meeting held on 24-3-2022 for an amount of Rs.595.23 Lakhs.

2. After careful examination of the matter, Government hereby accord Revised Administrative Approval to the Variation Estimate for an amount of Rs.579.00 Lakhs (Rupees Five Crores and Seventy Nine lakhs only) including tender discount @ (-) 2.99% for the work Construction of Check dam across Akeru Vagu near Jayapuram Village of Narsimhulapet Mandal, Mahabubabad District with the following conditions

- (i) The Chief Engineer (I) Warangal should ensure that the additional provisions made in the Revised Estimate are not attributable to the constructions defects.
- (ii) The Chief Engineer (Irrigation), Warangal is responsible for the correctness of quantities, rates and provision made in the Variation Estimate

3. The expenditure sanctioned in para (2) above shall be debited to the Head of Account "MJH 4702-00-101-07-10-530-531".

4. The Engineer-in-Chief (General), Hyderabad / Chief Engineer (Irrigation), Warangal shall take necessary action accordingly.
