In the reference read above, the Chief Engineer, Minor Irrigation (GB), Hyderabad has informed that 6 No. of works which were sanctioned under Mission Kakatiya Phase-I in Nizamabad District were not grounded due to the reason that, O.T. Sluices and weir cum causeway to be reconstructed; F.T.L. of the Tank is to be raised; Feeder channel to be excavated and bund has to be strengthened, etc., therefore, requested to cancel the administrative approval of the said works.

2. Government after careful examination of the matter, hereby cancel the administrative approval accorded in various G.O,s for 6 no. of works under Mission Kakatiya phase-I in Nizamabad District and the statement showing the details of tanks annexed to this order.
