ORDER:-

Government of Telangana has taken-up restoration of all Minor Irrigation Tanks in the State of their original capacity and to effectively utilize the 265.00 TMC of water allocated for Minor Irrigation sector under Godavari & Krishna River Basins as a flagship programme under the name of “MISSION KAKATIYA”.

2. In the reference read above, the Chief Engineer, Minor Irrigation (GB), Hyderabad has submitted proposal under Mission Kakatiya for “Restoration of Meedhi Cheruvu, H/o. Regunta(V), Metpally(M), Karimnagar District for according administrative approval.

3. Government after careful examination of the matter, hereby accord administrative approval for an amount of Rs.18, 93,000/- (Rupees Eighteen lakhs ninety three thousand only) for the work “Restoration of Meedhi Cheruvu, H/o. Regunta(V), Metpally(M), Karimnagar District”, under Mission Kakatiya Phase-II for the Financial Year 2016-17 subject to the responsibility of the Chief Engineer, Minor Irrigation (GB), Hyderabad, that the overall sanctions under Mission Kakatiya works shall remain within FRBM Norms and the expenditure shall not exceed the budget allotted during 2016-17 and to ensure the following before according technical sanction and the statement showing the details of tank proposed for restoration is annexed to this order:-

a) The provision made towards de-siltation in the estimates are based on the pre-levels and prudent assessments of quantities involved.

b) The cost of repairs indicated are as per the actual requirement of the related components and quantities for restoration of tank and the provisions including L.S Provisions made are in accordance to the Codal provisions and the guidelines issued in relation thereto.

4. The expenditure sanctioned in para (3) above shall be debited to the Head of Account “4702-00-101-11-23-530/531-O.E”.

5. The Chief Engineer, Minor Irrigation (GB), Hyderabad, shall take necessary action accordingly, complete the work within the stipulated period and submit the utilization certificate to Government.
