**ORDER:-**

The Chief Engineer, Minor Irrigation (KB), Hyderabad in his letters read above has requested the Government to Accord Administrative approval for the work "Construction of Check dam across Ubbala Vagu @Sy.No.39, Bekkam (Village), Chinnambavi (Mandal), Wanaparthy District" for an amount of Rs. 46.52 Lakhs as per the rates of SSR for year 2020-21.

2. After careful examination of the matter, Government hereby, accord Administrative Approval for an amount of Rs.28.00 Lakhs (Rupees Twenty Eight Lakhs only) for the work of Construction of Check dam across Ubbala Vagu @Sy.No.39, Bekkam (Village), Chinnambavi (Mandal), Wanaparthy District subject to the following conditions:

1. To follow the instructions issued vide Memo No. 5657/MIT/ A2/ 2016-1 dated 02-06-2016 and GO Ms No. 9 I&CAD (Irr.IV) Department, dated 07-02-1994. If any condition prescribed in above GO is not satisfied, the Chief Engineer should obtain the specific approval from the Government.
2. To obtain the feasibility report from the Ground water Department, before according the Technical sanction.
3. To obtain the approved designs and drawings from the Competent Authority before according the Technical Sanction.
4. Ascertain the correctness of quantities before according technical sanction.

3. The expenditure sanctioned in para (2) above shall be debited to the Head of Account "MJH 4700 Capital Outlay on Major & Medium Irrigation-SMJH - 01 Major Irrigation (Commercial) -MH 232 Kaleswaram Project GH-25 State Sector Schemes - SH 27 Canals and Distributories- 530 Major Works- 531 Other Expenditure.

4. The Engineer-in-Chief (General), Hyderabad/Chief Engineer (Irrigation), Wanaparthy, shall take necessary action as per rules accordingly.
