**ORDER:-**

In the G.O.1<sup>st</sup> read above, Government have accorded administrative approval for an amount of Rs.1128.24 lakhs for Restoration of Tanks in Karimnagar District. Wherein, Rs.107.39 lakhs were sanctioned for the work “Restoration of Kudi Cheruvu, Choppadandi (V) & (M), Karimnagar District”.

2. The Chief Engineer, Minor Irrigation (GB), Hyderabad in his letter 2<sup>nd</sup> and 3<sup>rd</sup> read above has submitted Revised administrative approval proposal to Engineer-in-Chief (IW), Hyderabad for the work “improvements and remodel the Kudi Cheruvu, Choppadandi (V) & (M), Karimnagar District under Mission Kakatiya and requested to place the revised estimate in the Committee of the Chief Engineers and communicate the approval at an early date.

3. Subsequently, based on the recommendations of the Committee of Chief Engineers, the Engineer-in-Chief (IW), Hyderabad has referred the said revised estimate proposal to Government vide his letter 3<sup>rd</sup> read above.

4. Government after careful examination of the matter, hereby accord revised administrative approval for an amount of Rs.2,23,50,000/-, (Rupees Two Crores Twenty Three Lakhs and Fifty Thousand only) for the work “improvements and remodel the Kudi Cheruvu, Choppadandi (V) & (M), Karimnagar District” under Mission Kakatiya subject to condition that entrustment of work as per Rules and procedures in vogue.
