It is to inform that, the Government of Telangana has planned to restore all MI Tanks (46531 Nos) in a phased manner by adopting a comprehensive programme for restoration of tanks to sort out farmers problems.

Accordingly in pursuant to the decision of the State Government, I & CAD Department has formulated a scheme o be known as "Mission Kakatiya" (Mana Ooru - Mana Cheruvu). As per said scheme it is proposed to accept donations both from resident as well as non resident Indian individuals and their associations.

As per the instructions of Govt vide Memo.No.2668/MI-T/A2/2015-2 Dt. 18.04.2015 Mission Kakatiya Trust has been formed and registered on 13.05.2015 with joint Sub-Register, Sanjeeva Reddy Nagar, Hyderabad under Deed No. Book 4-64/IV/2015. In the trust deed, it is mentioned that, the trust is entitled to open separate bank account for the purpose of accepting donations/grants form domestic or foreign donors and operate such account in such names as they may decide.

The Govt vide Memo.No.6097/MI.T/A2/2015-4 Dt.03.06.2015 have permitted for opening bank account and accordingly the account on Mission Kakatiya is opened in SBH, Durgagutta Branch, Hyderabad and SB A/C No.62400709179.

In order to accept donations from overseas Indians under Foreign contribution Regulation Act (FCRA) FCRA approval from ministry of Home Affairs, FCRA wing, New Delhi was obtained with registration number 368140011 vide letter No.II/21022/92(0042)/2015-FCRA II Dt.01.10.2015 and also to accept donations form Resident Indians and for IT exemptions to the donations received necessary approvals from Income Tax Dept. U/s 80G(5) (VI) of Income Tax act 1961, Trust Registration U/s 12 AA (1) (b) (i) of the incline tax act 1961 were obtained vide commissioner of Income Tax (Exemptions) letter No.F.No. CIT(E)/89 (12)/12 A & 80 G/2015-16 Dt.12.01.2016.

The trust is having PAN No: AAETMI00GG and TAN No: HYDM14019F respectively.

On web portal Mission Kakatiya, necessary link connections were given for adaption of Tanks, contributor Registration form, Know your tank, Tank Sanction status etc for which snap shots enclosed for ready reference.

In view of the above, All Superintending Engineers noted in the address entry are instructed to encourage the Mission Programme to donors who come forwarded to donate under adopt tank Guide lines in your Jurisdiction and to make the path for successful completion of Govt Prestigious programme with peoples participation.

- iii) The institution shall submit the statement of income and expenditure and other financial statements for the year ending 31.03.2015 and subsequent year(s) within the prescribed time before the prescribed authority.
- iv) The institution shall maintain the books of account regularly and also get them audited as required under clause (b) of subsection (1) of section 12A of the I.T. Act.
- v) The institution shall file the Return of Income regularly as stipulated under section 139(1) read with section 139(4A).
- vi) The institution shall maintain separate books of account in respect of business activity as stipulated in the proviso to clause (i) of sub-section (5) of section 80G. The donations received should not be used directly or indirectly for the purpose of business.
- vii) No Expenditure should be incurred which is of religious nature in any previous year in excess of five percent of its Total Income of that previous year.
- viii) No deduction under Section 80G shall be allowed in respect of any donation unless such donation is of a sum of money.

3. The institution shall fulfill the conditions specified in sub-section (5) of section 80G of I.T.Act, 1961.

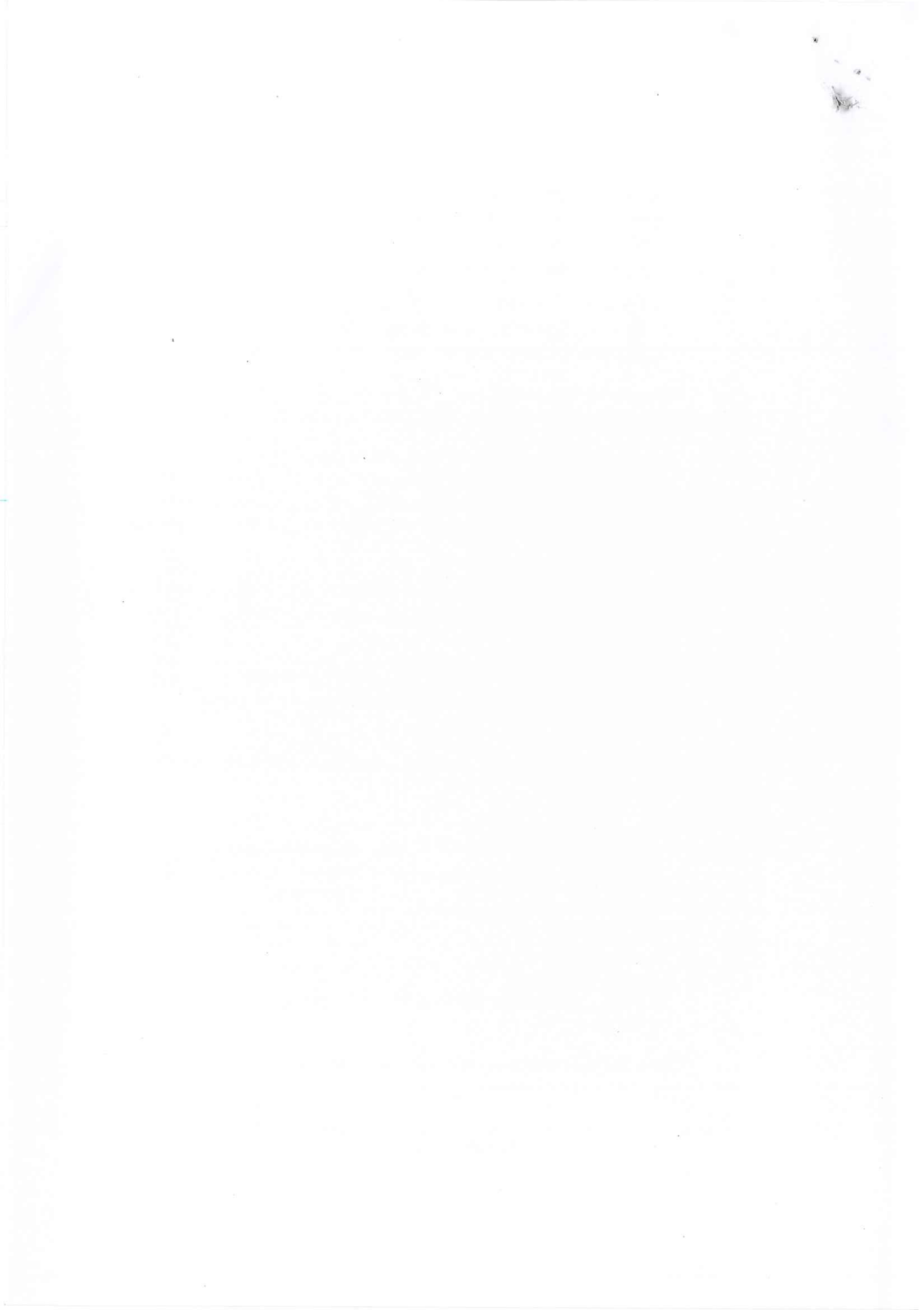

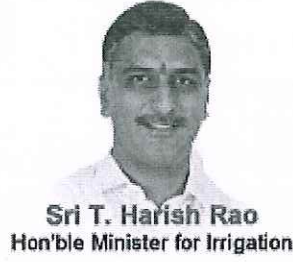

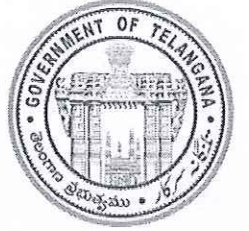

ADOPTION OF A TANK - GUIDELINES

1) Government of Telangana taken up a prestigious programme called Mission Kakatiya for restoration of all Minor Irrigation Sources in the state to restore them to its original capacity which directly increases the Irrigation Potential of said tank and to effectively utilize the 255 TMC of water allocated for Minor irrigation sector under Godavari & Krishna River basins. Apart from that, the villagers i.e., different Caste Communities like Fisherman, Dhobi, Goud Community, Farmers Community whose livelihood is directly or indirectly dependent on tanks will be benefitted. Due to several communities involvement, people will own the tank for its improvement. This concept made the Government to permit the interested people to "Adopt a Tank".

2) Government of Telangana is offering Adaption of a tank to any interested people / NRIs / organisations / NGOs etc who are voluntarily willing to take it up either by cash or kind contribution.

A. By Donation:

i. It is proposed to adopt a tank of their choice by anybody interested duly bearing the complete expenditure i.e., total cost of the Scheme. The name of the tanks will be prefixed with the name of the Donor.

Example: Original Tank Name: Pedda Cheruvu of -----Village----- Mandal. After adoption it is renamed as Venkaiah Pedda Cheruvu of ----- Village-----Mandal.

ii. If anybody proposed to donate a specific amount of Rs. 5.00 Lakhs / Rs. 1.00 Lakhs / Rs. 10,000/- to a specific tank, the name recommended by the donor along with donated amount will be written on the sign board placed at the tank site.

iii. Some people are donating simply for "Mission Kakatiya" Programme. Example: One day salary donated by the different categories of employees ie., Engineers JAC, NGOs etc., will be spent on Mission Kakatiya works in general.

B. (i) Some agencies like Builders Association of India are coming forward to execute the works with their men and machinery. In this connection it is permitted to execute the works with their men and machinery under the supervision of Irrigation officials as per the standards laid by the Department, after obtaining the Administrative Approval from the Government.

(ii) Some local people are coming forward to participate in execution of works by way of SRAMADANAM / SUPERVISION.

In such cases they would be informed to assist the AE / AEE / WI at site for such jobs (i) counting the number of tractors trips, (ii) whether the work being carried out as per the instructions of the department., (iii) Whether dumping of silt is being done in the fields of farmers or not. (iv) Whether curing of Cement Concrete Work is properly done or not. (v) To monitor the supply of water etc to the people working at site etc., It is only indicative duty / job chart for the persons / NGOs who wants to participate by way of SRAMADANAM / SUPERVISION. Their job chart will be decided by the concerned AE/AEE/ WI at site as per the requirement.

All the donations are to be given in the form of Cheque / DDs in favor of "**Chief Engineer, Mission Kakatiya**"

The role of the department:

1.The Executive engineer concerned is responsible for getting the work completed by the adopted person / agency as per the norms and procedures of the department.

2. The FTL boundaries are to be fixed before handing over the site of the tank to the donor / executor for grounding of the work by them.

The above activities will be looked by the Mission Kakatiya Trust.

3)The Chief Engineer, Minor Irrigation (GB/KB), Hyderabad is therefore, directed to take suitable measures for the issues raised in the paras 1 (g), (h) & (j) of third read above, in the aspect of certification and payments procedure by PAO's and deduction and adjustment of statutory recoveries to concerned Heads in cases of receipt of part donations for a particular tank or donations generally received in favour of the MK trust.

4) The Chief Engineer, Minor Irrigation (GB/KB), Hyderabad is also directed to examine for depositing the donations with the concerned PAOs as and when received in to the Trust for a particular tank and also as per the requirement for payment of work bills of tanks in general so that entire payments can be made by PAOs to avoid the possibility of double payments.

5) The Chief Engineer, Minor Irrigation (GB/KB), Hyderabad, shall take necessary action, accordingly.

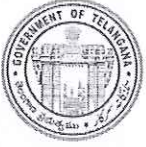

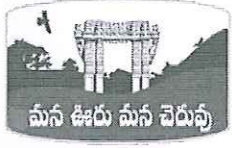
